AFFIDAVIT OF SURVIVORSHIP

Laing named in the Warranty Deed described herein; and that June G. Laing, undersigned, is one and the same person as June G. Laing named in said Warranty Deed.

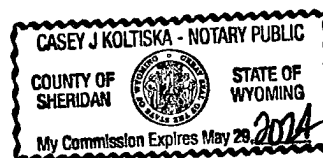
