PIPE LINE EASEMENT

THIS INDENTURE made this 28th day of September, 1953, between John M. Foster, Grantee, and B. F. and Rose Perkins Foundation hereinafter called the OWNER, Witnesseth that

IN CONSIDERATION of the payment by John M. Foster of the sum of One Dollar (\$1.00) and other valuable considerations, the OWNER does hereby grant, bargain and convey unto John M. Foster, his successors and assigns forever, the right, privilege, and authority to lay, construct, operate, maintain, repair and remove, a gas pipe line including necessary pipes, and fixtures, through, over, under, and across the following described real estate, in the County of Sheridan, State of Wyoming, to wit:

Part NE $\frac{1}{4}$  of the SW $\frac{1}{4}$ , Part E $\frac{1}{2}$  of the SE $\frac{1}{4}$   
Part SW $\frac{1}{4}$  of the SE $\frac{1}{4}$ , SE $\frac{1}{4}$  of the SE $\frac{1}{4}$   
located in Section 7, T54N, R83W, and  
SW $\frac{1}{4}$  of the NE $\frac{1}{4}$ , S $\frac{1}{2}$  of the NW $\frac{1}{4}$ , part E $\frac{1}{2}$   
of the SW $\frac{1}{4}$ , S $\frac{1}{2}$  of the SW $\frac{1}{4}$ , part NW $\frac{1}{4}$  of  
the SE $\frac{1}{4}$  located in Section 8, T54N, R83W.  
The above tract of land contains approximately  
441 acres more or less.

THE OWNER hereby grants to John M. Foster, his successors and assigns, the right to all reasonable times to enter upon said premises for the purposes of laying, constructing, maintaining, operating, repairing or removing said gas pipe line and for the purpose of doing all necessary work in connection therewith.

John M. Foster, by the acceptance hereof, hereby agrees that he will pay any and all damages that may result to the crops, fences, buildings or improvements on the above described premises, occasioned by constructing, maintaining, repairing, operating or removing of said gas pipe line.
