Right-of-Way Easement 516

KNOW ALL MEN BY THESE PRESENTS, that the undersigned Doe Makut and Mrs. Martha Kohut (unmarried) (husband and wife) for a good and valuable consideration, the receipt whereof is hereby acknowledged, does hereby grant unto SHERIDAN-JOHN-SON RURAL ELECTRIC ASSOCIATION, INC., a corporation, whose post office address is Sheridan, Wyoming, and to its successors or assigns, the right to enter upon the lands of the undersigned, situated in the County of Sheridan, State of Wyoming, and more particularly described as follows:

5E/4NE/4 Sec. 17 — T. 56N. RB2 W.

N/2NW/4: J/2NW/4 Sec. 20 — T. 54N. RB2 W.

N/2SE/4: Sec. 21-NW/4SW/4 sec. 22 — T. 55N. R. 82W.

and to place, construct, operate, repair, maintain, relocate and replace thereon and in or upon all streets, roads or highways abutting said lands an electric transmission or distribution line or system, and to cut and trim trees and shrubbery to the extent necessary to keep them clear of said electric line or system and to cut down from time to time all dead, weak, leaning or dangerous trees that are tall enough to strike the wires in falling.

In granting this easement it is understood that at pole locations, only single pole and appurtenances will be used, and that the location of the poles will be such as to form the least possible interference to farm operations, so long as it does not materially increase the cost of the construction.

The undersigned covenants that he is the owner of the above described lands and that the said lands are free and clear of encumbrances and liens of whatsoever character except those held by the following persons:
