Right of Way Deed

Know all men by these presents; that I Jacob Spren
a single man, of the County of Sheridan, State of Wyoming
in consideration of the sum of One Hundred (\$100.00)
Dollars, in hand paid, the receipt whereof is hereby confessed and
acknowledged, do hereby grant, bargain, sell and convey unto the Town of
Sheridan, Wyoming, a municipal corporation, the following described
real estate, in the County of Sheridan, State of Wyoming, to wit: -

The right to lay and construct and maintain to, over and across the
lands hereinafter described, a pipe line for the purpose of conducting
water to the Town of Sheridan, Wyoming, said pipe line to be covered
to the depth of at least four (4) feet, and also the perpetual right of way to

the extent of a strip of land ten (10) feet in width, to, over and across the said land in conformity with the Engineer's survey and plat now of record in the office of the Town Clerk of the Town of Shendaw Wyoming, and according to the line of said (pipe) being five (5) feet in width on each side of said pipe line, as the same shall be hereafter constructed, laid and maintained, to over and across said land, and containing in all about fifty six - one hundredths (.56) of an acre of land, together with the perpetual right of ingress, egress and regress, to, over and across the said described land within the line of said right of way, said land and line being described as follows, to wit: - Across the south west quarter of the North east quarter, and South east quarter of North west quarter of Section Seventeen (17) Township Eighty five (85) North, Range Eighty five (85) West, beginning at a point which is south seven hundred six (706) feet and one thousand five hundred five (1505) feet S sixty four (64) degrees and thirty (30) minutes west from the north east quarter of Section Seventeen (17) Township Eighty five (85) North, Range Eighty five (85) West, thence a distance of one thousand seven hundred two (1702) feet S sixty four (64) degrees and thirty (30) minutes west to a point, thence a distance of seven hundred twelve (712) feet South forty seven (47) degrees and thirty (30) minutes west to a point which is on the east and west center line of said Section Seventeen (17), the said strip of land being ten (10) feet in width, by two thousand four hundred twenty two (2422) in length.
