CERTIFICATE OF PARTIAL VACATION OF PLAT

Lots 3 and 4 of Heartland Subdivision, a subdivision in Sheridan County, Wyoming, as recorded January 6, 2005 in Drawer H, Plat #49 (the "Property");

WHEREAS, Owner desires to partially vacate said Property as shown on the Plat, and desires that the said Plat be partially vacated, as to the Property only, in accord with the fully-executed plat filed contemporaneously herewith at the office of the Sheridan County Clerk for the sole purpose of re-platting said Property.

THEREFORE, Owner hereby vacates that portion of the Property described above and the dedication of the Property is hereby revoked and terminated in accordance with the approval and consent of the Sheridan City Council. Owner, by these presents, does make the above partial vacation for it and for its successors and assigns, and for all future owners of said Property, as the same shall be re-platted as EMIT MINOR #1 SUBDIVISION.
