RIGHT-OF-WAY EASEMENT

KNOW ALL MEN BY THESE PRESENTS: That for and in consideration of the sum of One and no/100 ----- (\$1.00) Dollar and other good and valuable consideration, the receipt of which is hereby acknowledged, the undersigned, OLIVER M. WALLOP, a single man, Grantor, has and by these presents does hereby grant and convey unto ROBERT L. WALLICK and JOAN FORD WALLICK, husband and wife, Grantees, their heirs, executors, administrators and assigns, an easement and right-of-way across the following described real estate and premises owned by Grantor and situate in Sheridan County, State of Wyoming, to-wit:

A twenty (20) foot wide right-of-way which is located in the S $\frac{1}{2}$ NW $\frac{1}{4}$ of Section 30, Township 54 North, Range 84 West of the 6th P.M., Sheridan County, Wyoming, and is situated ten (10) feet to the right and left of a centerline described as follows:

Beginning at a point which is located N. 22° 42' 18" E., 2867.40 feet from the Southwest corner of said Section 30; thence N. 39° 23' 23" E., 30.15 feet to a point; thence N. 43° 14' 30" E., 635 feet to a point; thence N. 19° 03' 00" W., 550 feet to a point; thence N. 9° 10' 02" W., 98 feet to a point; thence N. 0° 02' 41" W., 91.7 feet to the point of ending.

The above described tract contains 0.7 acres more or less.

for the purpose of conveying water by pipeline from Wallop Spring No. 1, located at a point which is N. 22° 42' 18" E., 2867.4 feet from the Southwest corner of Section 30, Township 54 North, Range 84 West, to the following described lands:

A tract of land situate in the West half of Section 30, Township 54 North, Range 84 West of the Sixth Principal Meridian, Sheridan County, State of Wyoming, more particularly described as follows:

Beginning at a point which is North 28° 27' East, 4345 feet from the southwest corner of said Section 30, which point is the point of beginning; thence North 13° 25' East, 232 feet to a point; thence North 12° 14' West, 392 feet to a point; thence North 32° 38' West, 104 feet to a point; thence North 77° 31' West, 322 feet to a point; thence North 85° 33' West, 331 feet to a point; thence North 73° 07' West, 319 feet to a point; thence South 45° 05' West, 169 feet to a point; thence South 26° 37' West, 507 feet to a point; thence South 23° 03' West, 339 feet to a point; thence East 1515 feet to the point of beginning, said tract containing 24.1 acres.

construction, operation, maintenance, replacement and repair of Wallop Spring No. 1 and the pipeline for which this easement is given.
