PLAT SHOWING PARTS OF LOTS

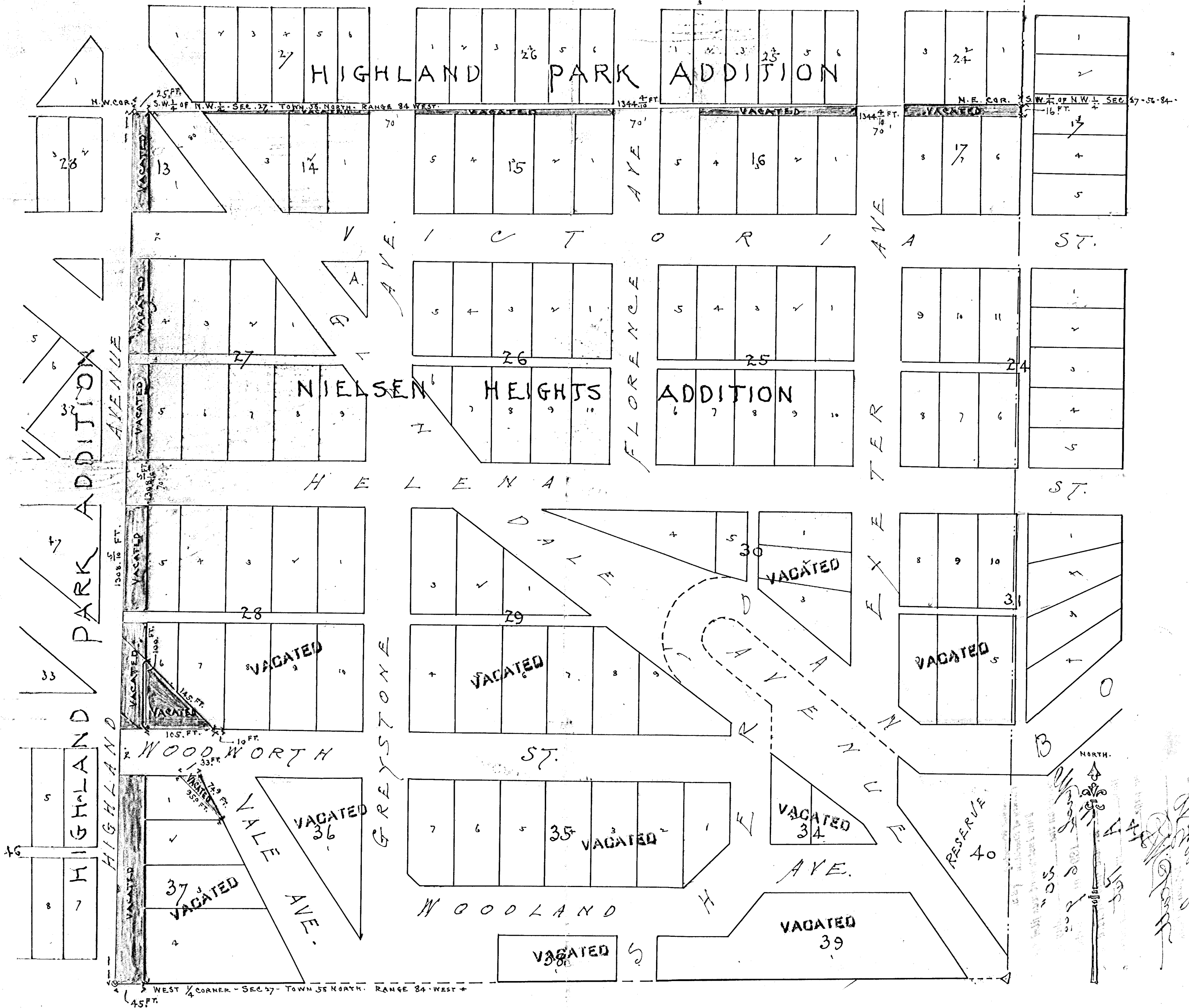

CERTIFICATE OF VACATION - KNOW ALL MEN BY THESE PRESENTS THAT I, ANDREW J. NIELSEN, of SHERIDAN, SHERIDAN COUNTY, WYOMING, OWNER AND PROPRIETOR OF THE FOLLOWING DESCRIBED LANDS, TO WIT: INITIAL POINT. BEGINNING AT THE N.W. CORNER OF THE S.W. $\frac{1}{4}$ OF THE N.W. $\frac{1}{4}$ OF SEC. 27 - TOWN 56 NORTH - RANGE 84 WEST. RUN EAST A DISTANCE 1344. $\frac{1}{10}$ FT. TO A POINT, WHICH IS THE N.E. CORNER OF THE S.W. $\frac{1}{4}$ OF THE N.W. $\frac{1}{4}$ OF SAID SEC. 27: THENCE SOUTH A DISTANCE 16. FT. TO A POINT: THENCE WESTWARD A DISTANCE 1344. $\frac{1}{10}$ FT. TO POINT OF BEGINNING, EXCEPT LOT 5 - BLOCK 16, NIELSEN ADDITION TO THE TOWN OF SHERIDAN, SHERIDAN COUNTY, WYOMING AND ALSO EXCEPT ALL LANDS PREVIOUSLY VACATED FOR STREETS AND ALLEYS. ALSO, BEGIN AT THE N.W. CORNER OF THE S.W. $\frac{1}{4}$ OF THE N.W. $\frac{1}{4}$ OF SAID SEC. 27: TOWN 56 NORTH - RANGE 84 WEST; RUN SOUTH A DISTANCE 1308. $\frac{5}{10}$ FT. TO A POINT, WHICH IS THE WEST $\frac{1}{4}$ CORNER OF SAID SEC. 27: THENCE EAST A DISTANCE 45. FT. TO A POINT: THENCE NORTHWARD A DISTANCE 1308. $\frac{5}{10}$ FT. TO A POINT 25. FT. EAST OF THE POINT OF BEGINNING: THENCE WEST A DISTANCE 25. FT. TO POINT OF BEGINNING: EXCEPT ALL LANDS PREVIOUSLY VACATED FOR STREETS AND ALLEYS. ALSO THE TRIANGULAR PIECE OF LAND DESCRIBED AS FOLLOWS: BEGIN AT A POINT, 10. FT. WEST OF THE SOUTH EAST CORNER OF LOT 7 - BLOCK 28 - NIELSEN ADDITION TO THE TOWN OF SHERIDAN - RUN WEST ALONG WOODWORTH STREET A DISTANCE 105. FT. TO A POINT: THENCE NORTHWARD A DISTANCE 100. FT. TO A POINT: THENCE SOUTH-EASTERLY A DISTANCE 145. FT. TO THE POINT OF BEGINNING. ALSO THE TRIANGULAR PIECE OF LAND DESCRIBED AS FOLLOWS: BEGIN AT THE SOUTH EAST CORNER OF LOT 1 - BLOCK 37 - NIELSEN ADDITION TO THE TOWN OF SHERIDAN - RUN IN A NORTH-WESTERLY DIRECTION ALONG VALE AVENUE, A DISTANCE 74. $\frac{2}{10}$ FT. TO A POINT, THE ORIGINAL NORTH-EAST CORNER OF SAID LOT 1 - BLOCK 37: THENCE WEST ALONG WOODWORTH STREET A DISTANCE 33. FT. TO A POINT: THENCE SOUTH-EASTERLY A DISTANCE 95. FT.
