## CERTIFICATE OF PARTIAL VACATION OF PLAT

WHEREAS, John E. Rice & Sons, Inc., a Wyoming corporation, (herein the "Owner"), is the sole record owner of the following described real property, to wit:

WHEREAS, Gone Fishing, LLC, a Wyoming Limited Liability Company, (herein the "Owner"), is the sole record owner of the following described real property, to wit:

The undersigned acknowledge that easements for existing utilities and State and County roads that may be within the boundaries of the vacated lands are reserved for continued use.

THEREFORE, Owner hereby vacates that portion of the Property described above and the dedication of the Property is hereby revoked and terminated in accordance with the approval and consent of the Sheridan City Council. Owner, by these presents, does make the above partial vacation for it and for its successors and assigns, and for all future owners of said Property, as the same shall be re-platted as THE MARKET PLACE – REV. 1.
