



CORRECTIVE WARRANTY DEED

Mary Lou A. Malli, Grantor, for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, receipt of which is hereby acknowledged, conveys and warrants to **R. LeRoy Malli**, Grantee, all of Grantor's interest in the following described property situate in Sheridan County, State of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State, to-wit:

The property described on the attached **Exhibit "A"**;

and the property described on the attached **Exhibit "B"** as recorded in Book 438, Page 484 of the Sheridan County Land Records;

less the property described on the attached **Exhibit "C"** as recorded in Book 438, Page 482 of the Sheridan County Land Records;

Together with all improvements thereon and all appurtenances thereto, or otherwise belonging, subject to all easements, restrictions and any other reservation of record.

EXCEPTING AND RESERVING to the Grantor, for her lifetime and her lifetime only, the possession and use of the dwelling in which she resides. Upon the expiration of the Grantor's natural life, the possession and use of said dwelling shall revert to the Grantee; and

EXCEPTING AND RESERVING to the Grantor, her successors and assigns, all oil, gas, coal, and other minerals, but not including sand, gravel, or aggregate in or on the above-described lands, together with the right to enter upon said lands and explore for and remove said oil, gas, coal and other minerals provided the owner of the surface is reasonably compensated for damage done thereto.

This deed is given to correct the legal description to include acreage that was inadvertently left out of that certain Warranty Deed dated May 3, 2017, and recorded May 9, 2017, in Book 566 at Page 496 of the Sheridan County Land Records, and to exclude acreage conveyed by the same Warranty Deed that was no longer owned by Grantor.
