Deed made this ______ day of July, 1996, by and between Rick Hanslip, personal representative of the Earl R. Hanslip estate, of Big Horn, Wyoming, hereinafter referred to as "Grantor", and the SHERIDAN AREA WATER SUPPLY JOINT POWERS BOARD, a joint powers board existing under agreement between the County of Sheridan, Wyoming and the City of Sheridan, Wyoming, hereinafter referred to as "Grantees".

For and in consideration of <u>Seven thousand nine hundred eighty eight and 18/100 dollars</u> (\$7,988.18), and other good and valuable consideration, Grantor conveys to Grantee an easement and right-of-way across and under the following described real property, described as:

for the purposes of surveying, constructing, installing, inspecting, operating, maintaining, repairing and replacing an underground water line, together with all appurtenances that may be necessary and convenient for the conveyance of water, together with the right of ingress and egress upon and across the real property of Grantor at reasonable places and routes for the aforesaid purposes.

This deed of easement shall be binding upon Grantor's heirs and assigns and shall be perpetual so long as the easement is used for the purposes above recited.

A temporary construction easement situated in the SE1/4 NE1/4 and SE1/4 Section 4, Township 54, Range 84 West, 6th P.M., Sheridan County, Wyoming, said easement being forty (40) feet southerly and westerly of the following described line , as shown on Exhibit "B" attached hereto and by this reference made a part hereof, said line being more particularly described as follows:

Beginning at a point located N89°16′18″W, 461.88 feet from the E ¼ corner of said Section 4; thence S31°24′57″W, 478.18 feet to the point of ending, said point of ending being located S27°51′33″W, 454.94 feet from the E¼ corner of said Section 4.

A temporary construction easement and a perpetual water line easement situated in the SE1/4 NE1/4 and SE1/4 Section 4, Township 54, Range 84 West, 6th P.M., Sheridan County, Wyoming, said temporary easement being forty (40) feet southerly and westerly of the following described line and the perpetual easement being twenty (20) feet northerly and easterly of the following described line, as shown on Exhibit "B" attached hereto and by this reference made a part hereof, said line being more particularly described as follows:

Beginning at a point located S27°51′33″W, 454.94 feet from the E 1/4 corner of said Section 4; thence S31°24′57″E, 225.25 feet; thence, S89°43′23″E, 76.40 feet to the point of ending, said point of ending being located S1°03′41″W, 443.92 feet from said E 1/4 of Section 4.

A temporary construction easement and a perpetual water line easement situated in the SE1/4 NE1/4 and SE1/4 Section 4, Township 54, Range 84 West, 6th P.M., Sheridan County, Wyoming, said temporary easement being forty (40) feet westerly of the following described line and the perpetual easement being twenty (20) feet easterly of the following described line, as shown on Exhibit "B" attached hereto and by this reference made a part hereof, said line being more particularly described as follows:
