This Termination and revocation Statement and Confirmation is made and entered into to be effective as of 5 p.m. Mountain Daylight Time (MDT) the 22th day of August 2022, by Nancy O. Geehan, owner of the following described real estate, situate in Sheridan County, State of Wyoming 82834:

A tract of land situated in the NWNW of Section 17 Township 53 North, Range 83 West of the Sixth Principal Meridian, Sheridan County, Wyoming, described as Follows:

Beginning at a point which is 483 feet East and 360 feet South of the Northwest corner of said Section 17: thence West 182.4 feet to a point in the center of the County Road; thence South 44 degrees East 102.1 feet to a point in the center of the County Road; thence South 25 degrees 19' East 62 feet to a point in the center of the County Road; thence south 8 degrees 52' East 30.7 feet to a point in the center of the bridge over South Piney Creek; thence Easterly along the center of said Creek to a point which is 483 feet East of the Northwest corner of said Section 17; thence North along a line which is 483 feet East of the Northwest corner of said Section 17 to the point of beginning.
