in hand paid, receipt whereof is hereby acknowledged, Convey and Warrant to Renzo H. Lomax  
Grantee, of Sheridan County, and State of Wyoming the following described real estate, situate in Sheridan County and State of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State, to-wit:

An undivided one-half interest in and to the following described lands:  
The Northwest quarter of the Southwest quarter of Section 31 in Township 57 North of Range 86 of the Sixth Principal Meridian, and the North three-quarters of the Southeast quarter of the Southeast quarter and the Northeast quarter of the Southeast quarter of Section Thirty-six (36) in Township 57 North of Range 87 West of the Sixth Principal Meridian; together with all water, water-rights, ditch and reservoir rights connected with or used in the irrigation of the above described lands or any part thereof; also two shares of stock in the Highline Ditch Company.  
The above named Grantor hereby expressly assumes and agrees to pay the existing mortgage on the above described premises given to E. B. Allan and Mary S. Allan.  
The Grantor herein, being the owner of the land hereinafter described, hereby grants the above named grantee, a right of way for a private road across Lot 4 of Section 1 in Township 56 North of Range 87 West of the Sixth Principal Meridian and the South quarter of the Southeast quarter of the Southeast quarter of Section 36 in Township 57 North of Range 87 West, all in Sheridan County, State of Wyoming, along the west side of Highline ditch, beginning at the county road and extending northerly across the lands last above described.
