

A G R E E M E N T

THIS AGREEMENT made this 6th day of June, 1949, by
and between Colvin B. Brown and Berniece Shaw Brown, hereinafter
known as the Parties of the First Part and Lloyd Watson and Flora
Watson, hereinafter known as the Parties of the Second Part.

WITNESSETH:

WHEREAS, in consideration of the payment of One Dollar
(\$1.00) and other valuable considerations, the receipt of which is
hereby acknowledged, the Parties of the First Part do hereby grant
unto the Parties of the Second Part, the right, privilege and author-
ity to construct, operate and maintain a water reservoir as now
located on lands owned by the Parties of the First Part to-wit
the Northwest quarter of the Northwest quarter and the West Half
of the Northeast quarter of the Northwest quarter of Section 36,
Township Fifty-Seven North Range 87 West, together with the
right to construct a supply ditch from Amsden Creek to said
reservoir through the following described lands now owned by the
Parties of the First Part to-wit the Southeast quarter of the
Northeast quarter of Section 35, the West Half of the Northwest
quarter and the West Half of the East Half of the Northwest
quarter of Section 36, Township 57 North Range 87 West, and an
additional ditch from said reservoir through the land of the Parties
of the First Part to-wit the West Half of the East Half of the
Northwest quarter of Section 36, Township 57 North Range 87 West,
for the purpose of diverting water of said reservoir to the lands
of the Parties of the Second Part located in the Northwest quarter
of the Southeast quarter of said Section 36, together with the
right of ingress and egress to said reservoir and ditches.

The Parties of the Second Part agree that they will maintain said reservoir and ditches in good condition and will do no damage to the lands of the Parties of the First Part in using the above right of ingress and egress.
