lands set forth above.

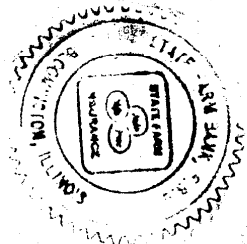

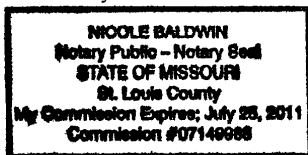

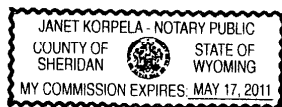
