- The Grantor acknowledges that he has been informed by Grantee that the 3. indebtedness secured by said Mortgage has become past due and all indebtedness would then become due and owing, and the Grantor is obligated to Grantee for the payment of said indebtedness by allowing the real property to be collateralized under Note by Grantor as Borrower and that as a result of such default, the Grantee is or would be entitled to foreclose said Mortgage.
- That the parties hereto have entered into an Agreement with the Grantor and Grantee and Borrower and under said Agreement, the Deed in Lieu is being executed in exchange for a full release of the indebtedness and obligations under the Note and Mortgage and this is a full release with all rights being transferred to KW Capital, Ltd.
