

ROAD MAINTENANCE AGREEMENT

THIS AGREEMENT made and entered into as of this 25 day of May, 1993, by and between the undersigned property owners in the Adkins Valley Subdivision, Tract 11-15, in Sheridan County, Wyoming, which use Adkins Valley Lane as a means of access for ingress and egress to their respective property.

THE UNDERSIGNED, for and in consideration of the promises, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, do hereby covenant and agree as follows:

1. The parties agree that each property owner of the Adkins Valley Subdivision, Tract 11-15 should be proportionately responsible for the maintenance costs for the Adkins Valley Lane from U.S. Highway 87 to the access road to their respective property.

2. Each of the undersigned do hereby promise and agree that they shall pay their respective share of the costs of the above described property, to maintain the Road in good and passable condition as determined by the said property owners.

3. From time to time, the property owners shall meet to determine what repairs and maintenance are necessary. Within 15 days after the completion of such repairs and maintenance, each property owner will remit his respective share for payment of the costs and expenses of said work.

4. Each of the parties signing this agreement agrees that the terms and conditions hereof shall be binding upon and inure to the benefit of any subsequent owners of any of said lots and they agree that upon conveying their interest in their respective property, they will cause the terms and conditions hereof to be assumed by any subsequent owners.

5. This agreement shall be in full force and effect for 30 (thirty) years from the date hereof, or until Sheridan County takes over the maintenance of the road, whichever shall occur the earliest.
