COMES NOW, Cheryl E. Barker, the record owner and proprietor of the following described real property to-wit:


**Tract One of Blue Grass Meadows Minor Subdivision No. 1.

THE FOREGOING PARTIAL VACATION is done for the purpose of replatting said lot as the Blue Grass Meadows Minor Subdivision No. 2.

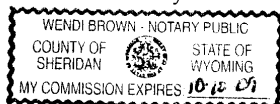




