## MEMORANDUM OF PURCHASE OPTION

• NOTICE IS HEREBY GIVEN that a PURCHASE OPTION AGREEMENT dated as of July 27, 2021 (the "<u>Agreement</u>") has been entered into by and among Bighorn Flats, LLC, a Wyoming limited liability company (the "<u>Company</u>") and BHF DEVELOPMENT, LLC, a Wyoming limited liability company ("<u>Managing Member</u>" or "<u>Grantee</u>"), and USA Institutional Bighorn Flats, LLC, the non-managing members of the Company.
