

LEGAL DESCRIPTION FOR ACCESS EASEMENT

AN ACCESS EASEMENT SIXTY (60) FEET WIDE, BEING THIRTY (30) FEET EACH SIDE OF THE FOLLOWING DESCRIBED CENTERLINE SITUATED IN THE EAST1/2SE1/4, NW1/4SE1/4, AND EAST1/2SW1/4 OF SECTION 22, TOWNSHIP 54 NORTH, RANGE 85 WEST, 6TH P.M., SHERIDAN COUNTY, WYOMING, SAID CENTERLINE BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:



TRACT 2 AS SHOWN ABOVE IS SUBJECT TO USE RESTRICTIONS CONTAINED IN CURRENT ZONING RESOLUTIONS AND NO ADDITIONAL RESIDENTIAL, COMMERCIAL OR INDUSTRIAL USE OR STRUCTURE SHALL BE PLACED ON TRACT 2 EXCEPT WITH THE WRITTEN PERMISSION OF THE BOARD OF COUNTY COMMISSIONERS OF SHERIDAN COUNTY, WYOMING AND THE OWNERS OF TRACT 1.




