Also, that portion of the NW4 of the SE4 lying south of a line described as follows:

Also, that portion of the SE% of the SW% lying south of a line described as follows:

This Easement shall be a general easement across all or any portion of the described tract of land except that when a road is actually constructed, travel and access shall be restricted to the constructed roadway. If the described parcel should be platted or subdivided this right-of-way shall be limited to the platted road in such future development. Any future development shall not preclude access to the STYX Subdivision by the owners of the STYX Subdivision or representatives of public bodies.
