The right of way hereby granted being more particularly described as follows:

A portion of Lot 14, Block 1 of the Mead Addition to the City of Sheridan described as follows:

Beginning at the northeast corner of said Lot 14 said corner being monumented by an aluminum survey cap;

thence southerly along the east boundary of said Lot 14 a distance of 10.0 feet; thence northwesterly a distance of 14.1 feet, more or less, to a point on the north boundary of said Lot 14;

north boundary of said Lot 14; thence 5.87°56'49.5"E. along said north boundary a distance of 10.0 feet, more or less, to the point of beginning.

The above described parcel of land contains 50.0 square feet, more or less.
