KNOW ALL MEN BY THESE PRESENTS:

That for and in consideration of the sum of Ten Dollars \$10.00 and other valuable considerations, the receipt of which is hereby acknowledged and confessed, TEXACO INC., a Delaware Corporation

of the County of __Sheridan and State of Wyoming, hereinafter called the grantor, hereby grants to THE TRANSPORTATION COMMISSION OF WYOMING, P.O. Box 1708, Cheyenne, Wyoming 82002-9019, its assigns or successors, hereinafater called the grantee, the right to lay out, construct, inspect, operate and maintain a road for the use of the public over and across the following described lands located in the County of Sheridan and State of Wyoming, to-wit: Portions of NEISE of Sec. 8; NW15W1 and W2NW1 of Sec. 9; SW15W1 of Sec. 4, all of T. 53 N., R. 83 W. of the 6th

The right-of-way hereby granted being more particularly described as follows:

1: All that portion of the NETSET of Section 8, T. 53 N., R. 83 W. of the 6th P.M., Wyoming, lying between parallel right-of-way lines (or as otherwise stated), said parallel right-of-way lines being of hereinafter stated distances apart when measured at right angles or radially to the following described survey line of highway, said parallel right-of-way lines begin on the east boundary of said Section 8 and end on the west boundary of said NEISET:

Commencing at a point on the east boundary of said Section 8 from which the southeast corner thereof bears S.0°28'24.3"W. a distance of 2,557.81 feet and the northeast corner thereof bears N.0°28'24.3"E. a distance of 2,673.00 feet;

thence with parallel right-of-way lines 200 feet apart, being 100 feet on, each side, S.90°00'00"W. a distance of 65.69 feet to the point of beginning of a 12°00' spiralled curve concave southeasterly, the spiral lengths of which are 240.00 feet, the total length of which is 744.16 feet and the total central angle of which is 60°29157.4";

thence continuing with the last described parallel right-of-way lines, westerly along the spiral arc of said curve through a central angle of 14°24' a distance of 240.00 feet;

thence continuing with the last described parallel right-of-way southwesterly along the circular arc of said curve through a central angle of 15°44'49.6" a distance of 131.23 feet;

thence with the northwesterly boundary of this parcel being said survey line of highway and the southeasterly boundary of this parcel being a parallel right-of-way line 100 feet to the left or southeasterly side, continuing southwesterly along said circular arc through a central angle of 15°57'07.8" a distance of 132.93 feet;

thence continuing with the last described boundaries, southwesterly along the spiral arc of said curve through a central angle of 14°24' a distance of 240.00 feet; thence continuing with the last described boundaries, continuing southwesterly along the circular arc of said curve through a central angle of 0°57'18.7" a distance

of 7.96 feet;

thence with parallel right-of-way lines 200 feet apart, being 75 feet to the right or northwesterly side and 125 feet to the left or southeasterly side, continuing southwesterly along said circular arc through a central angle of 18°53'14.4" a distance of 157.39 feet;

thence continuing with the last described parallel right-of-way continuing southwesterly along the spiral arc of said curve through a central angle of 14°24' a distance of 240.00 feet to the point of ending of said spiralled curve;

continuing with the last described parallel right-of-way lines, thence S.78°08'35.7"W. a distance of 132 feet, more or less, until said parallel right-ofway lines intersect the west boundary of said NE\setminus SE\square .

The above described parcel of land contains 505,630 square feet, more or less.

NOTE: All bearings and distances in these descriptions are based on the Wyoming State Plane Coordinate System, East Central Zone, modified to Wyoming Department of Transportation Coordinate System by an adjustment factor of 1.000300000.

There is excepted and reserved from the property unto the grantor herein, all gas, minerals and mineral estate of every kind and nature that can be removed from the ground without jeopardy to the maintenance or safety of public use or travel upon the surface estate and without using the surface of the property.

Grantor also grants the right of ingress and egress to and from the said land for any and all purposes necessary and incident to the exercise by the grantee, and the public, of the rights granted by this conveyance.

Grantee agrees to construct culverts of suitable size across such ditches and laterals of grantor as necessary for proper operation of his irigation system.

Grantors hereto do hereby waive and release all rights under and by virtue of the homestead exemption laws of the State of Wyoming insofar as affected by this conveyance.

Grantor will not use, or permit to be used, the conveyed property for any purpose whatsoever; that exclusive use is hereby granted to the grantee.

The grant herein contained is an easement and shall be perpetual so long as the main traveled portion of said land is used for the aforementioned purposes, and whether or not actually fenced or used in it entirety for the aforementioned purposes.
