AND DECREE OF FINAL DISTRIBUTION

The above entitled cause came on regularly to be heard this day upon the Final Accounting and Petition for Distribution and the two Supplemental Accountings filed by the Pirst National Bank of Sheridan, Wyoming, the duly appointed, qualified and acting Executor of the estate of Bessie Whedon, a/k/a Bessie F. Whedon, and pursuant to the Notice of Final Settlement of Estate, and due proof having been made of the publication and service thereof, and no objections having been filed to the Final Accounting or the Supplemental Accountings or to the Petition for Distribution for said estate, and the Court having considered the said Accountings and the Petition for Distribution and being duly and fully advised in the premises finds:

Bessie Whedon, a/k/a Bessie F. Whedon, died testate on February 3, 1968 in Sheridan, Wyoming, a resident of said County. That the decedent left personal and real property in said County.

That the Last Will and Testament of the decedent has been duly admitted herein to probate and on March 21, 1968 the First National Bank of Sheridan, Wyoming qualified as Executor of the estate of the decedent and was so appointed by this Court and Letters Testamentary were issued to it, and that said Letters are now in full force and effect.

3.

That the Executor caused a Notice to Creditors to present their claims to be published in a newspaper of general circulation in Sheridan County, Wyoming, the first publication having been made on March 22, 1968, and that the time within which creditors could file their claims has elapsed. That Creditors Claims have been filed herein and all claims filed have been paid in full.

4.

That all state, county and municipal taxes legally levied have now been paid, and that the inheritance tax upon the estate passing to the various heirs herein has been paid and that there is on file herein a Certificate of the Inheritance Tax Commissioner of the State of Wyoming showing payment of said inheritance tax; that all charges and expenses incurred in the administration of this estate have now been paid in full with the exception of an Executor's fee, a statutory attorney's fee, and extraordinary attorney's fees, certain out-of-pocket costs incurred by the attorneys which should be reimbursed, and an appraisal fee payable to Bridgeford-Holcomb-Jenrich, Inc. of

Sheridan, Wyoming in the amount of \$25,00 which was paid by the attorneys and should likewise be reimbursed.

5.

That the Executor has filed with the Internal Revenue Service an Estate Tax Return, as required by law, and in connection therewith, the Executor has paid all estate taxes due and owing from said estate, and that the District Director of Internal Revenue for the District of Wyoming has issued an Estate Tax Closing Letter accepting said Estate Tax Return as filed and acknowledging payment in full of all estate taxes.

6.

That the estate of the decedent now consists of personal and real property; and that the Executor has rendered a Final Accounting and Supplemental Accountings to the Court showing the receipts and disbursements during the probate of this estate; and that all disbursements are supported by true and correct vouchers. That said Final Accounting and Supplemental Accountings are in all respects correct and that the same should be allowed and confirmed.

7.

That the estate was duly inventoried and appraised by an Amended Inventory and Appraisement in the amount of \$302,138.57. That based upon the value of said estate the statutory Executor's fee is in the amount of \$6,392.77; that the statutory attorney's fee for said estate is in a like amount of \$6,392.77. That in addition thereto, there are certain items representing out-of-pocket expenses to the attorneys itemized as Exhibit "A" to the Final Accounting heretofore

filed in the amount of \$295.25 to which should be added the appraisal fee to Bridgeford-Holcomb-Jenrich, Inc. in the amount of \$25.00 for a total reimbursement to the attorneys for out-of-pocket expenses of \$320.25. That in addition to the statutory fee allowed the attorneys, there should be an extraordinary fee allowed herein for the defense of the action instituted to contest the Last Will and Testament of the decedent, which action was dismissed by this Court on May 7, 1969 pursuant to a settlement agreeable to all parties, and that a fair and reasonable extraordinary attorney's fee is the sum of \$1.000.000.

That under the Last Will and Testament of the decedent, Mike and Anna Suel were the sole heirs, legatees and devisees; however, as a result of the Will contest action instituted and pursuant to the Stipulation and Order entered on May 7, 1969 in said action, Mike and Anna Suel are to receive sixty percent of the distributable assets of said estate and the Contestants (who are set forth in Exhibit "A" appended hereto) are to receive forty percent of the distributable assets of the estate. That the Contestants are represented by William K. Archibald and Robert E. Holstedt, their attorneys, and that distribution of the Contestants' share of said estate should be made to William K. Archibald and Robert E. Holstedt as Trustees and attorneys

for the Contestants.

9.

That the Court should enter a Decree of Distribution setting over sixty percent of the distributable assets of the estate to Mike and Anna Suel and forty percent of the distributable assets of the estate to William K. Archibald and Robert E. Holstedt as Trustees and attorneys for the Contestants hereinafter listed on Exhibit "A".
