USE PERMIT

This Use Permit granted by the City of Sheridan, Wyoming, to Sierra Mobile Home Park and Sales, Inc., witnesses as follows:

WHEREAS the Sierra Mobile Home Park and Sales, Inc., a Wyoming corporation owns a motel building situate on the following described real property in the City of Sheridan, Sheridan County, Wyoming, to wit:

encroachment of any sort upon the public right-of-way shall occur.


