PIPE LINE EASEMENT

THIS INDENTURE made this 7th day of November, 1953 between School District No. 6 of Johnson County, Wyoming, Grantee and D. Orrel Geier and Vera M. Geier, husband and wife, hereinafter called the OWNER, Witnesseth that

IN CONSIDERATION of the payment by School District No. 6 of the sum of One dollar (\$1.00) and other valuable considerations, the OWNER does hereby grant, the right, privilege and authority to lay, construct, operate, maintain, repair and remove a gas pipe line, including necessary pipes and fixtures, through, over, under and across the following described real estate, in the County of Johnson, State of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State of Wyoming, to wit:

W half NW quarter, NW 1/4 SW 1/4 of Sec. 23

SW 1/4 NW 1/4 of SW quarter, SW 1/4 SE 1/4 of Sec. 26

NE 1/4 SE 1/4 and S Half of SE of Sec. 27

N half of NE 1/4 of Sec. 34, NW 1/4 NW 1/4 of Sec. 35, Twp. 53, Range 83,

All containing 680 acres more or less.

THE OWNER hereby grants to School District No. 6, their successors and assigns, the right to all reasonable times to enter upon said premises for the purposes of laying,
