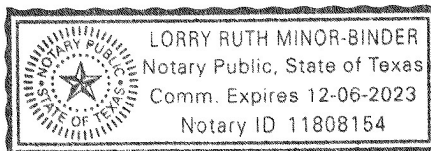

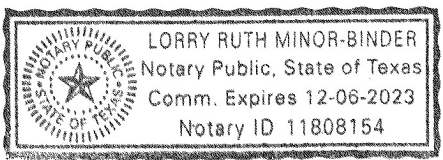




EXHIBIT A

A tract of land being that part of the N½ of the SE¼ and the SE¼ of the SE¼ of Section 7, T57N,R83W, 6th P.M., Sheridan County, Wyoming lying south of the Beatty Spur Road and West of the Beatty Gulch Road, and being more particularly described as follows:

Beginning at the South 1/16 corner of said Section 7, said corner being a 1.5" alum cap per LS 6594; thence N00°39'49"E along the north-south quarter section line of said Section 7 a distance of 1125.56 feet to the centerline of Beatty Spur Road; thence along the centerline of Beatty Spur Road the following eight (8) courses:

S65°39'30"E, 254.98 feet; thence Southeasterly 275.54 feet along the arc of a 3650.00 foot radius curve to the right which chord bears S63°29'45"E, 275.47 feet; thence S61°19'59"E, 94.17 feet; thence Southeasterly 528.55 feet along the arc of a 2250.00 foot radius curve to the right which chord bears S54°36'12"E, 527.34 feet; thence S47°52'25"E, 357.46 feet; thence Southeasterly 108.14 feet along the arc of a 2890.00 foot radius curve to the right which bears S46°48'06"E, 108.13 feet; thence S45°43'47"E, 122.02 feet; thence Southeasterly 252.30 feet along the arc of a 300.00 foot radius curve to the left which chord bears S69°49'21"E, 244.93 feet to the centerline of Beatty Gulch Road; thence along the centerline of Beatty Gulch Road the following four (4) courses:

S86°05'06"W, 116.49 feet; thence southwesterly 122.04 feet along the arc of a 100.00 foot radius curve to the left which chord bears S51°07'25"W, 114.60 feet; thence S16°09'44"W, 338.35 feet; thence southwesterly 118.66 feet along the arc of a 925.00 foot radius curve to the right which chord bears S19°50'14"W, 118.86 feet to the west line of the SE¼ of the SE¼ of said Section 7; thence N00°35'48"E along the west line of the SE¼ of the SE¼ of said Section 7, 461.16 feet to the southeast 1/16 corner of said Section 7, said corner monumented by a 2" aluminum cap per LS 5369; thence S89°39'05"W along the south line of the N½ of the SE¼ of said Section 7, 1330.54 feet to the point of beginning.
