TRACT 8 NE DECKER ROAD

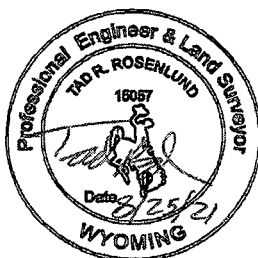
