PIPE LINE EASEMENT

THIS INDENTURE, made this 5th day of September A. D. 1930, between NORTHWEST STATES UTILITIES CO., a corporation, 831 Second Avenue South, Minneapolis, Minnesota, hereinafter called the "COMPANY," and Paul John Dodd and Margaret Dodd, his wife, of Sheridan County, Wyoming, hereinafter called the "OWNER," WITNESSETH that:

IN CONSIDERATION of the payment by the COMPANY of the sum of One (\$1.00) Dollar and other valuable considerations, the OWNER does hereby grant, bargain and convey unto the COMPANY, its successors and assigns, during the life of the present gas field, the right, privilege and authority to lay, construct, operate, maintain, repair, and remove, a gas pipe line including necessary pipes, regulators and fixtures, through, over, under and across the following described real estate, in the County of Sheridan, State of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption law of said State, to-wit:

West Half of Northwest Quarter ($W\frac{1}{2}NW\frac{1}{4}$) of Section Seventeen (17) and East Half of Northeast Quarter ($E\frac{1}{2}NE\frac{1}{4}$) of Section Eighteen (18), Township Fifty-four (54) North of Range Eighty-three (83) West of the Sixth Principal Meridian.

The company agrees to place a tap in the main pipe line at a

point on the owners premises to be designated by the owners and to furnish and install the necessary regulator and meter and to give the owners gas service at the same rates prevailing in the city of Sheridan from time to time for like service.

The OWNER hereby grants to the COMPANY, its successors and assigns, the right at all reasonable times to enter upon said premises for the purpose of laying, constructing, maintaining, operating, repairing or removing said gas pipe line and for the purpose of doing all necessary work in connection therewith.

The COMPANY by the acceptance hereof, hereby agrees that it will promptly and on demand pay any and all damages that may result to the owner, occasioned by presence constructing, maintaining, repairing, operating or removing of said gas pipe line.
