I, WALTER J. PUGH, OF SHERIDAN, WYOMING, HEREBY CERTIFY THAT THIS PLAT WAS MADE FROM NOTES TAKEN DURING AN AERIAL SURVEY MADE UNDER MY SUPERVISION DURING NOVEMBER, 1971, AND THAT THIS MAP CORRECTLY REPRESENTS ALL THE DATA SHOWN THEREON.
