RIGHT OF WAY EASEMENT

KNOW ALL MEN BY THESE PRESENTS, That the Denver Joint Stock Land Bank of Denver, a corporation organized and existing under and by virtue of the laws of the United States of America, grantor, for a good and valuable consideration, the receipt whereof is hereby acknowledged, does hereby grant and convey unto the Sheridan County

Electric Company, a corporation, grantee, whose post office address is Sheridan, Wyoming, and to its successors or assigns, the right to enter upon the lands of the grantor situated in the County of Sheridan, State of Wyoming, described as follows:

South One-half of Northwest Quarter (~~S~~¹/₂ NW ¹/₄) of Section thirty-three (33),

and South One-half of Northeast Quarter (~~S~~¹/₂ NE ¹/₄) of Section thirty-two (32),

Township Fifty-five (55) North, Range Eighty-four (84) West of 6th P. M.,

and to construct, operate and maintain on the above described lands and/or in and upon the streets, roads or highways abutting the same, an electric transmission or distribution line or system, including the necessary guy and brace poles, anchors and guy wires, and to cut and trim trees and shrubbery to the extent necessary to keep them clear of said electric line or system and to cut down from time to time all dead, weak, leaning
