

**GAS PIPELINE
RIGHT OF WAY AGREEMENT**

The undersigned Grantor(s) for and in consideration of ten dollars \$10.00) and other good and valuable consideration, the receipt whereof is hereby acknowledged, do hereby grant and convey unto **Redstone Gas Partners, LLC**, a Colorado Corporation, hereinafter referred to as "Grantee", whose address is 1999 Broadway, Suite 2250, Denver, Colorado 80202, its successors, assigns, lessees, licensees and agents a nonexclusive easement and the right to construct, operate, maintain and remove a natural gas and methane gas pipeline upon, over, under and across the following described land which the Grantor owns or in which the Grantor has any interest, to-wit:

A right of way across:

Township 57 North, Range 83 West, 6th P. M.

Section 29: SW4SE4

Section 32: E2

Section 33: W2

Township 56 North, Range 83 West, 6th P. M.

Section 5: Lots 1, 2, 3, 4, S2N2, SE4

Section 8: NE4

Section 9: W2

Section 16: Portions of NW4 & NW4NE4

Section 20: E2, SW4

Section 21: S2NW4, SW4, Portions of NE4NW4 & W2NE4

Section 29: ALL

Section 32: NW4

Section 31: NE4

more particularly described on surveyor's plat attached hereto as Exhibit "A" and by this reference made a part hereof.

Grantee shall have the right of ingress and egress to and from the above described easement in accordance with the surface damage agreement, the right to clear and keep cleared all trees and other obstructions as may be necessary. Grantee shall be responsible for all damage caused to Grantor arising from Grantee's exercise of the rights herein granted. The Grantor reserves the right to occupy, use and cultivate said easement for all purposes, and to grant such rights to others. The rights, conditions and provisions of the easement shall ensure to the benefit of and be binding upon the heirs, executors, administrators, successors and assigns of the respective parties hereto.

If Grantee fails to use the pipeline for transportation of gas any 24 consecutive months period, then and in that event, this Right-of Way shall be deemed abandoned and this Right-of Way Agreement shall automatically terminate and be of no further legal force or effect.

This right of way agreement is subject to a surface damage agreement, which is to run with the right of way agreement. A copy of said Surface Damage Agreement is in the possession of the parties and should be consulted for specifics.

A twenty (20) foot wide pipeline easement located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 32 and the W $\frac{1}{2}$ of Section 33, T57N, R83W, and the E $\frac{1}{2}$ of Section 5, the E $\frac{1}{2}$ NE $\frac{1}{4}$ of Section 8, the W $\frac{1}{2}$ of Section 9, and the N $\frac{1}{2}$ NW $\frac{1}{4}$ of Section 16, T56N, R83W, of the 6th. 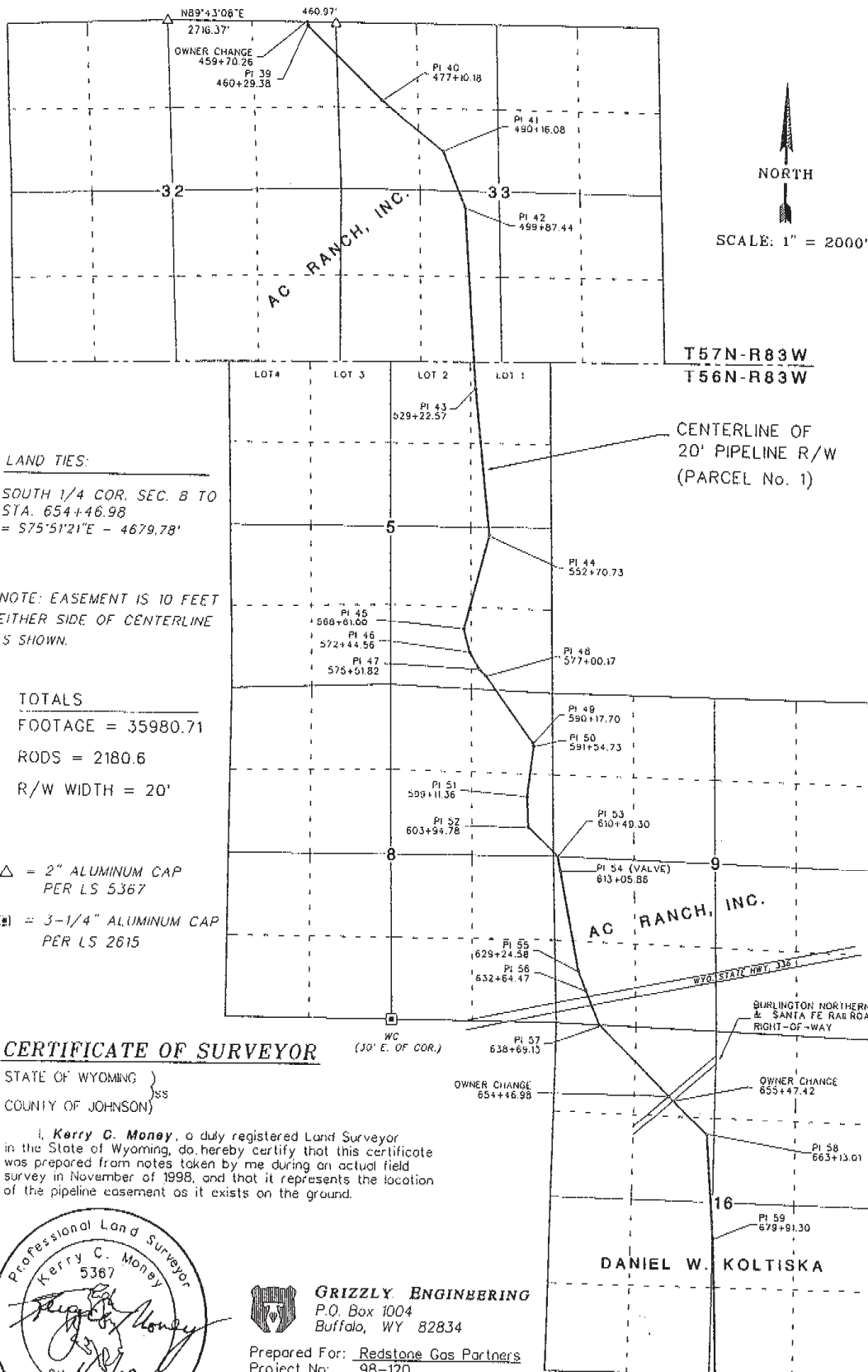

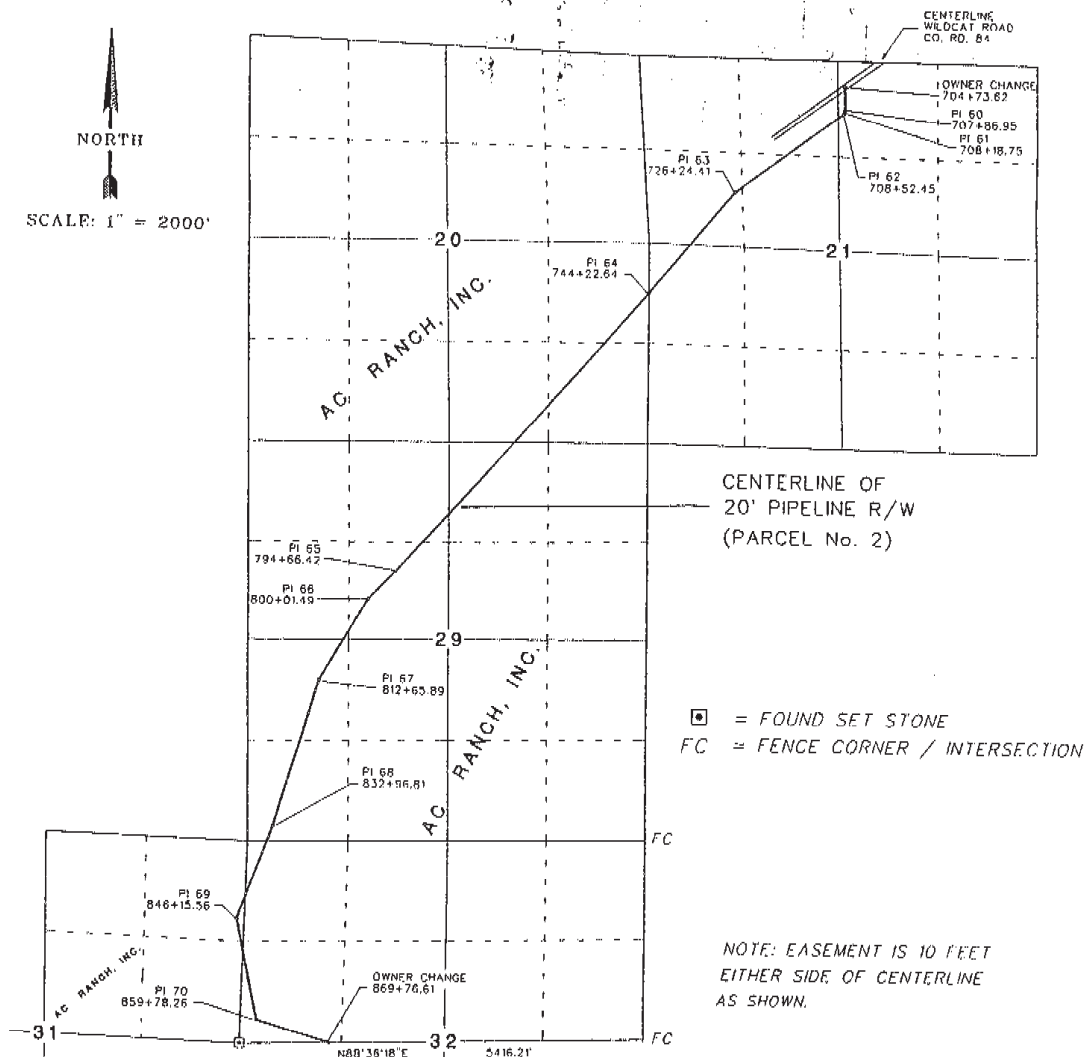

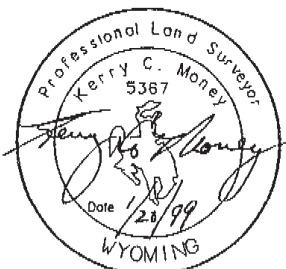
