ADDENDUM

Addendum to the Rights-of-Way Easement from Allen F. Willey for a buried telecommunications cable, according to Wyoming State Law.

Commencing at the Southeast corner marker of Section 22, T55N, R83W of the Principal Meridian Wyoming, thence North 33°0' West for a distance of 2000 feet to the point of beginning of the buried telecommunications cable.

Thence North 35°0' West for a distance of 700 feet. Thence North 5°0' East for a distance of 1000 feet. Thence North 10°0' West for a distance of 900 feet. Thence North 35°0' East for a distance of 300 feet. Thence North 60°0' West for a distance of 500 feet. Thence North 40°0' East for a distance of 600 feet.
