KNOW ALL MEN BY THESE PRESENTS: That, Frank A. Barrett, Governor; C. J. Rogers, Secretary of State; J. R. Mitchell, State Treasurer; Everett T. Copenhagen, State Auditor, and Edna B. Stolt, Superintendent of Public Instruction; acting as the Board of Land Commissioners of the State of Wyoming, hereinafter called Grantor, for and in consideration of One Dollar (\$1.00) and other good and valuable considerations does by these presents grant, bargain, sell and convey unto Montana-Dakota Utilities Co., Inc., a Delaware Corporation, authorized to do business in the State of Wyoming, hereinafter called Grantee, and unto its successors and assigns the following described property situate in the County of Sheridan, State of Wyoming, to-wit:

That certain gas pipe line connecting the main line of Grantee with the metering point at the "Wyoming Girls' School" near Sheridan, in Sheridan County, Wyoming, said line being located in Sections 10 and 11, Township 55 North, Range 84 West of the Sixth Principal Meridian and more particularly described as follows: Beginning at station 0700, which is marker post 102 on the main gas line of the Grantee, said post being South 59° East 2485 feet from the Northwest corner of Section 11, Township 55 North, Range 84 West, thence North 88°15' West 750 feet, thence North 87°03' West 1460 feet, thence North 89°42' West 1250 feet; thence North 81°01' West 1350 feet; thence North 65°41' West 1260 feet to a point that is South 68° West 1245 feet from the North one-quarter of Section 10, Township 55 North, Range 84 West of the Sixth Principal Meridian, Sheridan County, Wyoming.

Grantor expressly states that this conveyance has been executed pursuant to and in conformity with a resolution duly passed and adopted by the Board of Land Commissioners of the State of Wyoming.
