GENERAL WARRANTY DEED

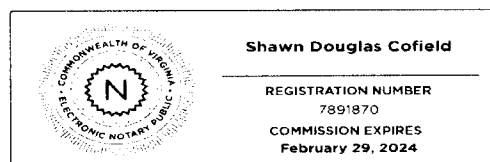
