the following described real estate, situate in SHERIDAN County and State
 of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State,

 DESCRIBED AS BEGINNING AT A POINT 470' W. OF THE SOUTHEAST CORNER
 OF SAID NW $\frac{1}{4}$ NE $\frac{1}{4}$; THENCE RUNNING NORTH A DISTANCE OF 579 FEET, MORE OR
 LESS, TO THE SOUTH LINE OF THE COUNTY ROAD; THENCE WEST ALONG THE
 SOUTH LINE OF THE COUNTY ROAD TO THE WEST LINE OF SAID NW $\frac{1}{4}$ NE $\frac{1}{4}$; THENCE
 SOUTH TO THE SOUTHWEST CORNER OF SAID NW $\frac{1}{4}$ NE $\frac{1}{4}$; THENCE EAST ALONG THE
 SOUTH LINE OF SAID NW $\frac{1}{4}$ NE $\frac{1}{4}$ TO THE POINT OF BEGINNING, ALL IN SECTION 10,
