A right of way 10 feet in width for a sewer line for the Wyoming Girls' Industrial Institute, being 5 feet on each side of the present sewer line under and across the NW1NE1 of Section 10, in Township 55, North of Range 84, West of the Sixth Principal Meridian, Sheridan County, Wyoming; also a right of way in the NW1NE1 of said Section 10 adjacent to the present septic tank of sufficient size for a filtration bed east from the septic tank. All together with full rights of ingress and egress for the purposes of construction, maintenance, repairs, reconstruction and inspection of the said sewer line, septic tank and filtration bed; reserving, however, to The Wyoming Securities Company, its successors and assigns, a right in the said company to use the said septic tank and such parts of the sewer line constructed and to be constructed by the State of Wyoming as may be necessary and convenient for the conveyance of sewage from the buildings of The Wyoming Securities Company to such septic tank.
