

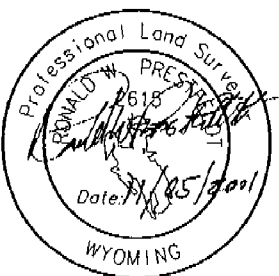
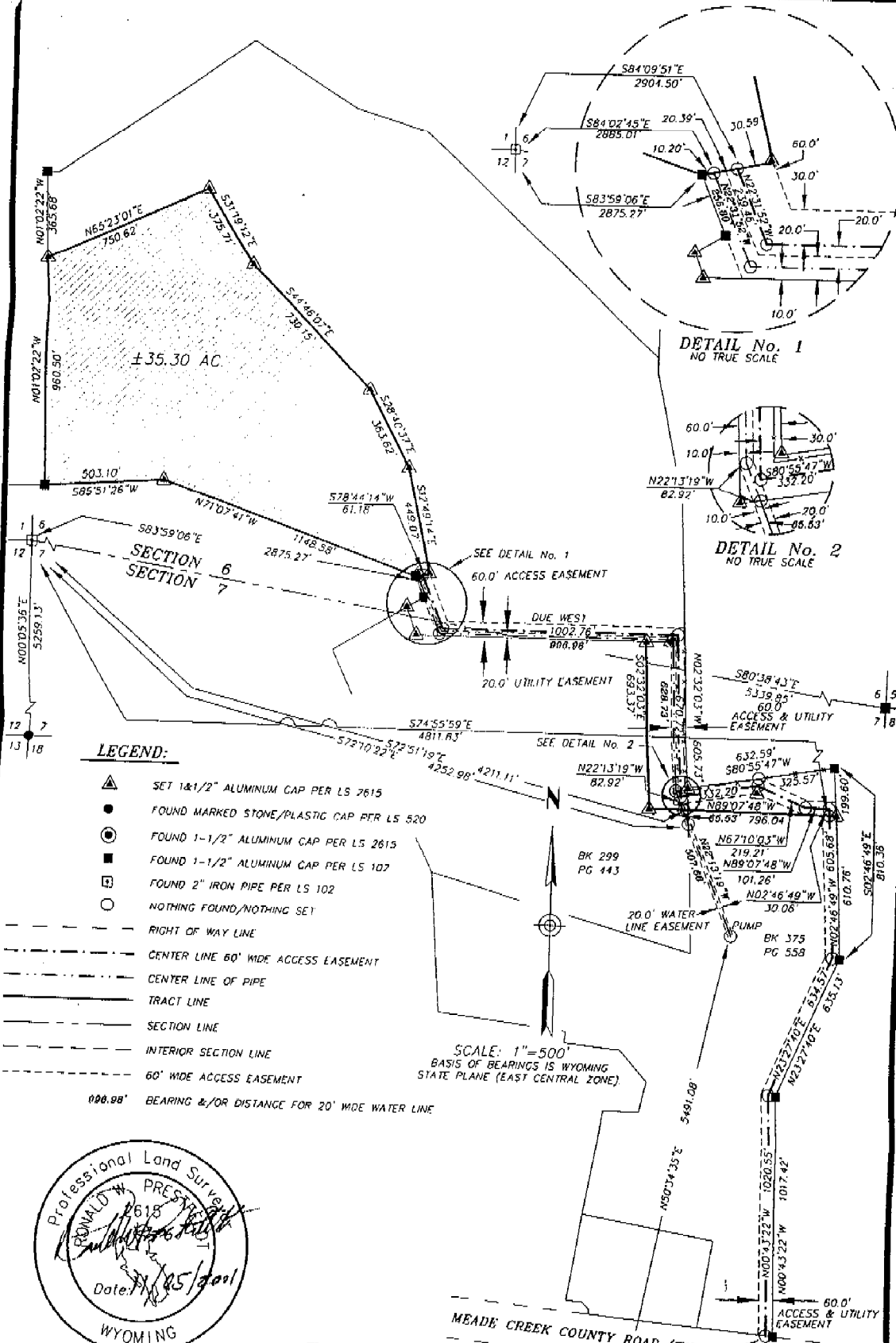

EXHIBIT A

A strip of land twenty (20) feet wide, ten (10) feet each side of the following described centerline situated in the North½ of Section 7, Township 54 North, Range 83 West, 6th Principal Meridian, Sheridan County, Wyoming as shown on **Exhibit "B"** attached hereto and by this reference made a part hereof; said centerline of said strip being more particularly described as follows:

Commencing at the southwest corner of said Section 7, thence N50°34'35"E, 5491.08 feet to the **POINT OF BEGINNING** of the herein described twenty (20) foot wide water line easement; thence N22°13'19"W, 507.68 feet along said centerline to the **POINT OF TERMINUS** of said twenty (20) foot wide water line easement, said point lying on the west line of a tract of land recorded in Book 375 of Deeds, Page 558 and being S72°10'22"E, 4252.98 feet from the northwest corner of said Section 7.
