DECREE FOR DISTRIBUTION OF REAL PROPERTY

THIS MATTER having come before the Court on the <u>Verified Application for Decree of Summary Distribution of Real Property</u> ("<u>Application</u>") filed by the Petitioner, Dirk Cairns-Gallimore, and the Court, after holding a hearing on August 2, 2023, finds as follows:

- 1. Jim Ronald Gallimore ("Decedent") died intestate in Sheridan County, Wyoming, on June 4, 2022. More than thirty (30) days have passed since the death of Decedent.

Under Wyo. Stat. Ann. § 2-4-101, Petitioner and Deborah L. Brandt are entitled to 8. distribution of the real property described above, and there are no other heirs having a right to succeed to said real property interest under probate proceedings or otherwise.

- Under Wyo. Stat. Ann. §§ 2-4-211-212, any claims of unsecured creditors on Property 9. 1 and Property 2 and claims by future purchasers of the real property of Decedent from Petitioner and Deborah L. Brandt shall be barred if no letters testamentary or of administration are issued by June 4, 2024, for the Decedent.
- Property 1 and Property 2 shall pass to Petition and Deborah L. Brandt subject to any 10. existing liens and encumbrances of record.

NOW THEREFORE, IT IS ORDERED, ADJUDGED, AND DECREED THAT:

- The Verified Application for Decree of Summary Distribution of Real Property sworn A. to and signed by the Petitioner is hereby accepted and approved.
- All Decedent's interests in Property 1 and Property 2 as of his date of death are В. distributed to Petitioner Dirk Cairns-Gallimore, and Deborah L. Brandt.
