SUBJECT to all easements, reservations, restrictions and covenants of record.



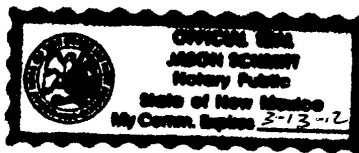

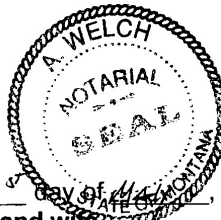
