the receipt whereof is hereby confessed and acknowledged, have remised, released, and forever quitclaimed
and by these presents do for their heirs, executors and administrators,
remis, release and forever quitclaim unto the said RICHARD WAYNE REECE and
DIXIE LYNNE REECE, their

heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as
they have or ought to have, in or to all the following described premises, to-wit:

Township 53 North, Range 83 West, 6th P.M.

Beginning at the southwest corner of said Lot 4 thence
north along the west line of Lot 4 as shown on the
official plat thereof, a distance of 238 feet to the
northwest corner of said lot, thence east along the
north line of said Lot 4, a distance of 35.8 feet to
a point, thence south 8°30' west to the point of
beginning.

Hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the
State of Wyoming.

TO HAVE AND TO HOLD the said premises unto the said RICHARD WAYNE REECE and
DIXIE LYNNE REECE, their
heirs and assigns, to his and their own proper use and behoof forever. So that neither
WILLIAM H. LAWRENCE and SYLVIA LAWRENCE,

of, but they and every one of them shall by these presents be excluded and forever barred.

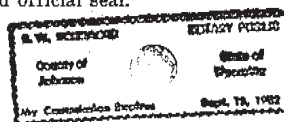
