CERTIFICATE OF PARTIAL VACATION OF PLAT

Owner, by these presents, does make the above partial vacation for it and for its successors and assigns, and for all future owners of said Property, as the same shall be re-platted as TRACT B, TURKEY TREE MINOR SUBDIVISION.
