PARTIAL VACATION OF PLAT AND RE-PLAT

WHEREAS, Child Development Center-Region II, a Non-profit corporation, (herein "Owner") as its interests appear of record, owns the following described real property:

Lots 6, 7, 8 and the East 35 feet of Lot 5, Block 7, Thurmond's Second Addition to the Town, now City of Sheridan, State of Wyoming, also known as Lot A and Lot C of the Linden Hill Subdivision, as recorded January 22, 2015, in Book L of Plats, Page 27, Sheridan County, Wyoming;

WHEREAS, the City of Sheridan, (herein "Owner") as its interests appear of record, owns the following described real property:

Block Numbered Three (3) in the First Addition to the Residence Hill Addition to the Town, now City of Sheridan, Sheridan County, Wyoming, also known as Lot B of the Linden Hill Subdivision, as recorded January 22, 2015, in Book L of Plats, Page 27, Sheridan County, Wyoming;

WHEREAS, the above described owners are referred to hereinafter collectively as the "Owners" and the above-described Lots hereinafter collectively as the "Lots";

WHEREAS. Owners desire to vacate said Lots as being a portion of that subdivision known and shown on the Plat of Thurmond's Second Addition, as amended by the Plat of Linden Hill Subdivision, and desire that said Plats be partially vacated as to said Lots, and the Lots be re-platted in accord with the fully executed plat filed contemporaneously herewith at the office of the Sheridan County Clerk for the purpose of correcting the platting said Lots as the "Corrected Plat of Linden Hill Subdivision", which said plat is incorporated herein by reference;

WHEREAS, there are no other lots, tracts or parcels that have access to a public highway through said Lots, whether by easement for right of way or otherwise which would be adversely affected by the replat of said Lots;

WHEREAS, the undersigned acknowledge that any easements for existing utilities and public roads that may be within the boundaries of the vacated Lots are reserved for continued use to the extent necessary and not otherwise dealt with on the re-plat of the Lots; and

WHEREAS, partial vacation of Thurmond's Second Addition plat and the First Addition to the Residence Hill Addition plat, as previously amended by the Plat of Linden Hill Subdivision, as to the above-described Lots would not reduce the value of other lots and tracts in the Subdivision;

THEREFORE, Owners hereby vacate that portion of Thurmond's Second Addition and Linden Hill Subdivision more particularly described above. The dedication of the Lots is hereby revoked and terminated in accordance with the approval and consent of the Sheridan City Planning Commission and the Mayor of Sheridan, Wyoming. Owners, by these presents, do make the above partial vacations for it and for its successors and assigns, and for all future owners of said Lots, together with as the same shall be re-platted as the Corrected Plat of the Linden Hill Subdivision.
