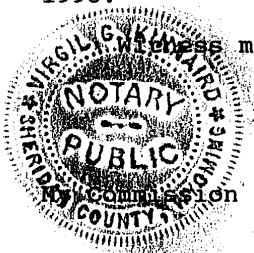

## TONGUE RIVER QUARRY TRACT - I

A tract of land located in the South One Half of the Northwest One Quarter (S 1/2 NW 1/4) and the North One Half of the Southwest One Quarter (N 1/2 SW 1/4), Section 21, Township 57 North, Range 84 West of the 6th Principal Meridian, Sheridan County, Wyoming more particularly described as follows:

Beginning at a point which is located on the East-West Centerline of Section 21, T 57 N, R 84 W which bears S 89° 55' 43" W, a distance of 3,099.52 feet from the East One Quarter Corner of said Section 21; Thence N 2° 32' 38" W, a distance of 1,105.46 feet to a point in the south Right-Of-Way line of the Burlington Northern Railroad; Thence S 82° 33' 45" W along the said Right-Of-Way of said Burlington Northern Railroad a distance of 310.92 feet to the Point-Of-Curve; Thence along said Right-Of-Way Curve to the Right having a Central Angle of 10° 50', a distance of 1,102.21 feet, the Chord of which bears S 87° 58' 45" W, a distance of 1,100.60 feet to the Point of Tangency; Thence N 86° 36' 15" W along said South Right-Of-Way line a distance of 27.25 feet to a point; Thence S 10° 40' 15" E, a distance of 1,330.45 feet to a point; Thence N 86° 17' 35" E, a distance of 1,249.62 feet to a point; Thence N 2° 32' 38" W, a distance of 199.92 feet to the point of beginning.

A tract of land located in the North One Half of the Southwest One Quarter (N 1/2 SW 1/4), Section 21, Township 57 North, Range 84 West of the 6th Principal Meridian, Sheridan County, Wyoming more particularly described as follows:

Beginning at a point which bears S 89° 55' 43" W along the East-West Centerline of Section 21, T 57 N, R 84 W, a distance of 3,099.52 feet; Thence S 2° 32' 38" E, a distance of 199.92 feet from the East One Quarter corner of said Section 21; Thence S 86° 17' 35" W, a distance of 1,249.62 feet to a point; Thence S 10° 40' 15" E, a distance of 168.00 feet to a point; Thence N 86° 17' 35" E, a distance of 119.07 feet to a point; Thence S 71° 49' 00" E, a distance of 689.09 feet to a point; Thence N 57° 29' 47" E, a distance of 533.34 feet to a point; Thence N 2° 32' 38" W, a distance of 166.79 feet to the point of beginning.
