and by these presents do for themselves, their heirs, executors and administrators,  
remise, release and forever quitclaim unto the said Sheridan County, itsheirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as they  
may have or ought to have, in or to all the following described premises, to-wit:Beginning at the Southwest corner of Tract 1-1, Resubdivision of Tracts 1  
and 2 of Resubdivision of Lots 12 and 13 of Paradise Park Subdivision,  
Sheridan County, Wyoming;Thence North 0°36'33" West along the Westerly boundary of Tract 1-1, a  
distance of 30.02 feet to a point;Thence South 88°34'10" East parallel to the Southerly boundary of Tract 1-1,  
a distance of 647.48 feet to a point lying on the East boundary of  
Tract 1-1;Thence South 0°45'15" West along the Easterly lot boundary of Tract 1-1,  
a distance of 30.00 feet;Thence North 88°34'10" West along the South boundary of Tract 1-1, a  
distance of 646.77 feet to the point of beginning.Said parcel being the South 30.00 feet of Tract 1-1, containing 0.45  
acres, more or less.Hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the

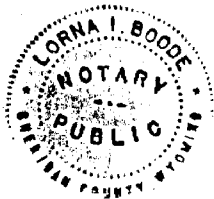
