AGREEMENT MADE this day by and between JAMES F. AURAND AND SHARRON M. AURAND, 429 WYARNO ROAD, SHERIDAN, WYOMING 82801, being the legal owner(s) (hereinafter referred to as "Licensors"), of TRACT 36, DON ENA ESTATES SUBDIVISION, SHERIDAN COUNTY, WYOMING, EXCEPTING THAT PORTION CONVEYED BY WARRANTY DEED RECORDED MAY 20, 1981 IN BOOK 257 OF DEEDS, PAGE 355., a Subdivision in Sheridan County, Wyoming, as recorded April 5, 1974, in Book 1 of Plats, Page 122, (herinafter referred to as "Subdivision"), and the Sheridan Area Water Supply Joint Powers Board, a joint powers board existing by and pursuant to the laws of the State of Wyoming, a body politic and body corporate, of Sheridan County, Wyoming (hereinafter referred to as "Licensee"):

WHEREAS:

1.

All of the lot owners of said Subdivision have an easement appurtenant for the use of the roads and streets of said Subdivision, as platted and dedicated by that certain plat of said Subdivision.

2.

By application dated APRIL 26, 1989, Licensor has applied for a tap to receive potable domestic water from Licensee.

3.

In order for Licensee to deliver potable domestic water to Licensor, Licensee must install, construct, maintain, repair and replace a water pipeline and appurtenant facilities within, along, under and beside the roads and streets of said Subdivision.

WHEREFORE, PREMISES CONSIDERED, Licensor grants to Licensee the right, permission and authority to construct, install, maintain, repair and replace a water pipeline and necessary facilities above or below ground surface within, along, on or below the roads and streets of the Subdivision.

Further, Licensee agrees that:

1. Installation, construction, maintenance, repair and

replacement of the water pipeline and appurtenant facilities will be accomplished in a manner that will reasonably cause the least interference with use of the roads and streets of said Subdivision by others entitled to use of said roads and streets.

- 2. All disturbance of roads and streets and their surfaces will be reclaimed and restored to the condition prior to disturbance at the sole cost of Licensee.
- 3. The water pipelines and necessary facilities shall be placed within the roads and streets of the Subdivision.
- 4. Licensee is responsible for coordinating the placement of its water pipeline and appurtenant facilities with other utilities within the roads and streets of said Subdivision as appropriate.
- 5. All buried water pipelines shall be minimum depth of six feet to the top of the line unless otherwise stated. All fire hydrants, flushing hydrants, air and vacuum valves, pressure-reducing valves, gate valves, booster stations, manholes, meter pits, curb stops, vent pipes, enclosures and other appurtenances, extending to the ground surface, shall be located as close as possible to the edge of the road and street right-of-way lines where practicable. Wherever located, they shall be designed for traffic, drainage or other conditions as applicable. All disturbed surfaces shall be restored as nearly as possible to their original condition.
- 6. If undue settlement of trenches occurs within one (1) year, Licensee shall establish by regrading or other methods all trenches to a uniform and acceptable condition.

This License Agreement shall be binding upon the heirs, assigns, representatives, trustees and successors-in-interest to the parties hereto.
