Chris Schroeder and Adele Schroeder, husband and wife, and A. E. Adkins and Edna Adkins, husband and wife, Grantor, R.
of Sheridan, Sheridan County, and State of Wyoming, for and in consideration of
Two Thousand Six Hundred and no/100 DOLLARS,
in hand paid, receipt whereof is hereby acknowledged, Convey and Warrant to Marie A. Wunsch and Hilda B. Wunsch,
Grantee, R., of Sheridan County, and
State of Wyoming the following described real estate, situate in Sheridan County
and State of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of
the State, to-wit:

Two and One-half (2½) Acres, more or less, of Tract A of Brundage Place accordingly as
recorded in the plat thereof on record in the office of the County Clerk and Ex-Officio
Register of deeds, County and State aforesaid, together with improvements thereon, and
One-seventieth (1/70) of a cubic foot of water per second of time of the George Brundage
Appropriation from Little Goose Creek priority territorial October 29, 1881, through
the Burn Cleugh Ditch and One-Seventieth (1/70) of a cubic foot per second of time carry-
ing capacity in said ditch, said 2½ Acres being more particularly described as follows:
Beginning at a point six hundred twenty-seven (627) feet South and Four hundred twenty-
seven (427) feet East of the NW corner of said Tract A, thence East on a line parallel
to the North line of said Tract A a distance of five hundred seventy-five (575) feet to
a point on the West right-of-way line of the Sheridan-Buffalo Highway, thence in a
southwesterly direction on said right-of-way line two hundred forty-nine (249) feet to
a point, thence in a westerly direction a distance of five Hundred forty (540) feet to a
point, which point is one hundred seventy-eight (178) feet South of the point of be-
ginning, thence North one hundred seventy-eight (178) feet to the point of beginning.
Subject to the taxes of 1937 and all subsequent taxes, and subject to an easement of right-
of-way thereon as located on and along the South line of said 2½ Acre Tract.
