

DESCRIPTION

ATRACT OF LAND LOCATED IN THE WY SEYA AND SWYANEY4 OF SECTION 35, TSGN, R84W, GTH P.M., AND TRACTS G,B,9 AND 10, ZND BRUNDAGE PLACE, CITY OF SHERIDAN, SHERIDAN COUNTY, WYOMING, DESCRIBED AS FOLLOWS:
