TEMPORARY DEED OF EASEMENT

This Temporary Deed of Easement is entered into this day of Lemma, 2015, by and between Samuel Damon and Janette Mydland, husband and wife, with an address of 2930 West 17th Street, Sheridan, Wyoming, 82801, (hereinafter the "Granter"), and the United States of America and its assigns (hereinafter the "Grantee"). Grantors do hereby grant and convey, for and in consideration of Four Hundred Sixty Dollars (\$460.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, unto Grantee, its successors and assigns, a temporary easement and right of way for the installation of underground water lines for a period of twelve (12) months that will allow the Grantee to utilize the surface of the property as a staging ground for personnel, equipment, construction materials, and other items as determined by the Grantee (the "Temporary Easement"). The Temporary Easement shall extend ten (10) feet from the outer boundaries of the permanent easement area encumbered in perpetuity, as depicted and described within Exhibit B, "Legal Description of Property" and on Exhibit B-2, "Survey of Easement Area," attached hereto and made a part hereof.

The Grantors' property, upon which the Temporary Easement is situated, is located in the County of Sheridan, State of Wyoming. The acquiring federal agency is the Department of Veterans Affairs ("VA").

The Temporary Easement is granted subject to the following conditions and provisions:

- 1. That the Grantors reserve unto themselves rights for all purposes across, over, or under the Temporary Easement herein depicted or described; such rights, however, to be exercised in a manner which will not create undue interference with the use and enjoyment by the Grantee of said Temporary Easement, and are not covenanted by the Grantors in another part of this Temporary Deed of Easement.
- 2. Grantors covenant and agree that no building, structure or other above-ground improvement shall be erected or constructed on the Temporary Easement without VA's prior written consent, and that the present grade or ground level of the property depicted and described in Temporary Easement shall not be changed by excavation or filling without VA's prior written consent (both of which consents may be withheld in the sole and absolute discretion of VA). Any construction by the Grantors in connection with the rights so reserved shall be at the expense of the Grantors.
- 3. Except in the event of an emergency, Grantee shall provide a minimum of forty-eight (48) hours written advance notice to Grantors prior to initiating work under the terms of this Temporary Easement detailing the commencement of the twelve (12) month period and the estimated period of construction anticipated by Grantee affecting Grantors' property.
- 4. The Grantee shall replace, repair, restore, or relocate any property of the Grantors affected or damaged directly or indirectly by the construction, reconstruction, installation, operation, maintenance, and replacement of said facilities.

5. The easement granted herein shall run with land, burden the Temporary Easement area, as more particularly described in Exhibit B-2, attached hereto and incorporated by reference herein.

- 6. The liability, if any, of the United States of America for injury or loss of property, or personal injury or death shall be governed exclusively by the provisions of the Federal Tort Claims Act.
- 7. This instrument shall be binding upon Grantors, Grantee and their respective successors, successors-in-title and assigns. As used herein, the terms Grantors and Grantee shall be deemed to be refer individually and collectively to the Grantors, Grantee and their respective successors and successors-in-title and assigns.
