That I have been a resident of the city and county of Sheridan, State of Wyoming, since March 1923; that I was personally acquainted with one Cornelius H. Grinnel,

who on Nov. 24, 1913, conveyed by warranty deed to one W.S. Bowen the following lot in said City of Sheridan, to-wit:

Lot 1 in Block 8 of the West View Addition to Sheridan, Wyoming.

That I personally known that at the date of said deed and for some time prior to said date that neither the said Cornelius H. Grinnel, nor his wife, Lillian M. Grinnel, lived on or occupied said land as a homestead; that the said lot was then vacant property, having no improvements on it. That at said time the said Lillian M. Grinnel, wife of said Cornelius H. Grinnel, was living at Newcastle, Wyoming, and said Cornelius H. Grinnel lived in Sheridan, Wyoming, but did not occupy the said premises.

DEED OF EASEMENT

This deed made the 2nd day of
December 1924, by and between Kendrick-
Irvine Corporation, a corporation organized
and existing under and by virtue of the
laws of the State of Wyoming, and Sheridan-
Wyoming Coal Company, a corporation organized
and existing under and by virtue of the laws

of the State of Delaware, (hereinafter called the Grantors) and Sheridan County Electric Company, a corporation organized and existing under and by virtue of the laws of the State of New Jersey (hereinafter called the Grantee).

WITNESSETH, That the grantors in consideration of the sum of one dollar and other valuable consideration to them in hand paid by the grantee, the receipt whereof is hereby confessed and acknowledged, do hereby grant and convey to the grantee and its successors and assigns the right, privilege and easement, in perpetuity, to enter upon, occupy, and use, for the purpose of dumping ashes, cinders and other waste and refuse from its Power Plant situated on adjacent lands, and only so long as the grantee, its successors or assigns, shall maintain and operate a Power Plant so situated the following described tract of land situated in Sheridan County, Wyoming, and particularly described as follows, to-wit:

Beginning at the northwest corner of the tract of land owned by the grantee and now occupied and used by the grantee as its Power Plant and situated in the north half of the southwest quarter (N $\frac{1}{2}$ SW $\frac{1}{4}$) of Section fifteen (15) of Township fifty-seven (57) north, of range eighty-four (84) west of the sixth principal meridian, which corner is marked by a cement monument; thence running north 24° 54' east, 227.9 feet to a point; thence north 86° 14' east, 400 feet, to a point; thence south 3° 46' east, 200 feet to the cement monument situated at the northeast corner of the said land of the grantee; thence south 86° 14' west, along the northerly boundary line of the said land of the grantee, 509.5 feet to the point of beginning.

And in consideration of the easement above granted the grantee covenants and agrees to and with the grantors that in such use of the land above mentioned, it will not injure or destroy their irrigating ditch running over and across the said land and will indemnify and save harmless the grantors and their successors and assigns from any loss or damage in consequence of such use of said land. And that the right to mine and remove coal from and under said premises is reserved to the grantors.

QUITCLAIM DEED

THIS DEED made the 11th day of March 1925,
by and between SHERIDAN COUNTY ELECTRIC COMPANY,
a corporation, duly organized and existing
under and by virtue of the laws of the state of
New Jersey (hereinafter called the grantor)
and KENDRICK-IRVINE CORPORATION, a corporation
organized and existing under and by virtue of

the laws of the State of Wyoming (hereinafter called the grantee)

WITNESSETH, That

WHEREAS, by deed dated the 23rd day of July, 1910, and filed for record in the office of the county clerk of Sheridan County, Wyoming, on the 23rd day of January 1917, and recorded in Book 7 of Deeds at page 288, J.B. Kendrick and W.C. Irvine conveyed to the Sheridan Electric Light & Power Company, the predecessors in interest of the grantor herein, a certain tract of land particularly described in said deed; and

WHEREAS, by deed dated the 24th day of September, 1910, and filed for record in said county clerk's office on the 15th day of October, 1910, and recorded in Book V of Deeds at page 352; John B. Kendrick and Eula W. Kendrick, his wife, and William C. Irvine conveyed to Sheridan County Electric Company, the grantor herein, a tract of land particularly described in said deed; and

WHEREAS, the descriptions of the lands described in said deeds, respectively, overlap each other, and the grantor herein desires to convey to the grantee all that part of the land described in the deed first above mentioned, which lies outside of the boundary lines of the tract mentioned and described in the second deed above mentioned, and further desires to convey to the grantee a triangular strip of land lying along the southerly side and included in the land mentioned and described in the second deed above mentioned;

NOW, THEREFORE, the grantor, in consideration of the sum of one dollar and other valuable consideration to it in hand paid by the grantee, the receipt whereof is hereby acknowledged, does hereby remise, release and forever quitclaim unto the grantee, and unto its successors and assigns all its right, title and interest in and to the following tracts of land situated in Sheridan County, Wyoming, and particularly described as follows, to-wit:

First: All that certain tract of land, consisting of 2.627 acres, more or less, situated in the north half of the southwest quarter (N $\frac{1}{2}$ SW $\frac{1}{4}$) of Section fifteen (15) Township Fifty-seven (57) north of Range eighty-four (84) west of the sixth principal meridian and bounded and described as follows: Commencing at a point which is north 31° 43' East,
