AFFIDAVIT OF SURVIVORSHIP

- 1. This Affidavit is made, executed, and recorded pursuant to Wyo. Stat. Ann. § 2-9-102.
- 2. I am Amy L. Urick's sister. Her husband, Randolph J. Urick, is the first named Agent under the General Power of Attorney of Amy L. Urick, dated May 26, 2011. Randolph J. Urick is deceased. I am the next named successor Agent appointed under the General Power of Attorney of Amy L. Urick, dated May 26, 2011. I have accepted the successor Agent appointment.
- 3. I certify that Randolph J. Urick, a/k/a Randolph Jon Urick, died on November 30, 2023, in Sheridan, Sheridan County, Wyoming. Attached hereto is a true certification of the official Death Certificate of Randolph Jon Urick certified to by the public authority in which the original Death Certificate is a matter of record.
- 4. On September 10, 2021, Anna Marie Perdue, as Grantor, executed and delivered a Warranty Deed to Randolph J Urick and Amy L Urick, husband and wife, as tenants by the entirety, as Grantees. The Warranty Deed was recorded on September 24, 2021, as Document No. 2021-772756, in the Office of the Sheridan County Clerk, Sheridan County, Wyoming, and conveyed to the Grantees the following described real estate, situate in Sheridan County, State of Wyoming:

- 5. The effect of the Warranty Deed referred to in paragraph 4 was to create a tenancy by the entireties in and to the property described in paragraph 4 in Randolph J. Urick and Amy L. Urick.
- 6. Upon the death of Randolph J. Urick, the tenancy by the entireties in and to the property described in paragraph 4 terminated, and Amy L. Urick became the sole owner in fee simple of the property described in paragraph 4.
